entered into in accordance with Act No. 25/2007 Coll. on Electronic Toll Collection for the use of specified sections of roads and on amending and supplementing certain acts as amended (hereinafter referred to as "Act on Electronic Toll Collection") between SkyToll, a.s., registered office at Westend Square, Lamačská cesta 3/A, 841 04 Bratislava, Slovak Republic, recorded in the Business Register of District Court Bratislava I, section Sa, insert no. 4646/B, Company ID No. 44 500 734, Tax ID No. 202 271 2153 (hereinafter referred to as the "System Operator"), represented by a person empowered/authorised in this matter by the System Operator, and the Vehicle Operator, as specified below.

C. Subject of the Contract

By signing this Contract the System Operator, after entering into the Contract on the Use of Specified Road Sections, commits to enable the Vehicle Operator to use the Specified Road Sections pursuant to Act on Electronic Toll Collection and the Vehicle Operator commits to provide a deposit for each On-Board Unit and its accessories as a security for the return of the On-Board Unit and its accessories. In accordance with the General Business Terms and Conditions of the Toll Collection Administrator and the General Business Terms and Conditions of the System Operator, the On-Board Unit has to be installed in the vehicle by fixed installation. All the delivery and takeover declarations of the On-Board Units form an indivisible part of this Contract.

I declare that all the data is complete and accurate and at the same time by attaching my signature I grant my consent to the System Operator and/or persons authorised by it for electronic storage of my data for the purpose of processing, use and handling of claims. I approve of all the indivisible parts of the Contracts, namely Annex 1 "General Business Terms and Conditions of the System Operator" and the List of Fees. This Contract is produced in two copies; one copy is intended for the Vehicle Operator and the other one for the System Operator.
