 WE WISH TO HAVE OUR ELECTRONIC MEDIA ADJUSTED

We are in possession of electronic media of DARS d.d. for non-cash toll payment in the Republic of Slovenia which are listed in the attachment P-1 by type of medium, serial numbers (for ABC and DC) and identification numbers (for ABC). For each vehicle for which toll will be paid in future with respect to the EURO emission class, the registration number and EURO emission class has been specified.

 WE WISH TO ORDER NEW ELECTRONIC MEDIA

As specified in the attachment P-1, we wish to order new electronic media (ABC and/or DC) for our vehicles as listed in the attachment, including the registration numbers and EURO emission classes.

Conditions for obtaining the DARS card or the electronic ABC tag (used) as defined in the applicable Toll tariff for the use of toll roads.

Mark the post-payment electronic media in the fifth column of the attachment P-1 by adding letter P to the designation of the electronic medium (ABC-P, DC-P). DC cards used as a post-payment medium, for which a prior Deferred Toll Payment Contract has to be concluded with DARS d.d. or which will be connected with a valid payment card upon collection, are distributed free of charge and without preloaded credit.

In the case of false information for adjustment or issue of electronic media for toll payment in respect of EURO emission classes or the use of these media contrary to General Conditions, we undertake to pay the underpaid toll for all journeys conducted on toll roads in the Republic of Slovenia on the basis of an invoice issued by DARS d.d..

DARS d.d. undertakes to enable toll payment by electronic media for the vehicles which are the subject of this application within 30 days of receipt of a complete application with the attachments. Use of the electronic medium for toll payment with respect to the EURO emission class will be enabled upon receipt of electronic notification by DARS d.d. stating that the information on the vehicle has been entered into the electronic toll collection system. The information will be automatically recorded on the electronic medium upon the first passage of the vehicle through the so-called combined lane of the toll station, marked thus

For combinations of vehicles in which the drawing vehicle with or without the trailer moves from R3 to R4 and vice versa, it is recommended that in addition to an ABC electronic tag for the toll-rate category in which most journeys are performed, a DC card is issued to pay for the toll-rate category other than the one recorded on the ABC electronic tag.
