The passage list TIS PL France – gross transactions



- » In order to make the invoicing of the gross transactions WA005G (partial payment) more transparent for you, a **new passage list “TIS PL – gross transactions** (before invoicing of the discounts and fees of the motorway companies)” will be introduced for partial payments
- » Sorting is by box number and then chronologically in ascending order
- » **No passage list** is enclosed with a **credit for partial payment**
- » If you already receive the passage list as csv file, the new list “TIS PL France – gross transactions” will be sent to you **in a separate mail**
